WHEREAS, the Borough has determined to undertake a fair and open process in accordance with the New Jersey Local Unit Pay-to-Play Law, N.J.S.A. 19:44A-20.5; et seq. through the issuance of Requests for Qualifications ("RFQ's") for contract awards for such services required on and after the Borough's 2025 Reorganization through December 31, 2025; and

WHEREAS, the Borough advertised the RFQ's for various professional and consulting services on its website and the League of Municipalities, the responses to which were due no later than November 15, 2024; and

WHEREAS, the Borough received qualifications and proposals from various firms in response to the RFQ's, which have been reviewed and are available for public inspection; and

WHEREAS, the Borough wishes to adopt a list of firms as qualified to provide services to the Borough pursuant to the RFQ process, which list is attached hereto.


NOW, THEREFORE, BE IT RESOLVED that the Mayor and Council of the Borough of Kenilworth hereby adopts the attached list as the firms deemed qualified to provide services to the Borough during the above-referenced time period pursuant to a Fair and Open process in accordance with the New Jersey Local Unit Pay-to-Play Law, N.J.S.A. 19:44A-20.5, et seq.; and

BE IT FURTHER RESOLVED that this Resolution does not, nor shall it be construed to award any contract under the RFQ process; and

BE IT FURTHER RESOLVED that this resolution shall take effect immediately.
