

**RESOLUTION
KENILWORTH, NJ**

**RESOLUTION AWARDING A GOODS AND SERVICES CONTRACT TO NATIONAL FUEL OIL CO,
FOR THE PURCHASE OF DIESEL PURSUANT TO NEW JERSEY STATE CONTRACT**

WHEREAS, the Borough of Kenilworth ("Borough") pursuant to N.J.S.A. 40A:11-12a and N.J.A.C. 5:34-7.29(c), may, by resolution and without advertising for bids, purchase any goods or services under the State of New Jersey Cooperative Purchasing Program for any State contracts entered into on behalf of the State by the Division of Purchase and Property in the Department of the Treasury; and

WHEREAS, the Mayor and Council of the Borough desires and requires the purchase of goods and services necessary for the purchase of diesel for the Borough from National Fuel Oil Co. through New Jersey State Contract No. 19-FOOD-01100; and

WHEREAS, the Mayor and Council of the Borough anticipates entering into a contract in excess of \$31,000 with National Fuel Oil Co. through this resolution and properly executed purchase orders/contracts, which shall be subject to all the conditions applicable to the current State contracts.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Kenilworth, County of Union, State of New Jersey that:

1. The Borough's Qualified Purchasing Agent is authorized to purchase goods and services necessary for the purchase of diesel for the Borough from National Fuel Oil Co. through New Jersey State Contract No. 19-FOOD-01100, which shall be subject to all the conditions applicable to the current State contracts, in an amount not to exceed Thirty-One Thousand Dollars and Zero Cents (\$31,000.00), for the period of January 1, 2025 through December 31, 2025.
2. The Borough of Kenilworth's Chief Financial Officer has certified that sufficient uncommitted funds are available in the 2025 Borough of Kenilworth Budget for the purposes set forth herein and the fund to be charged shall be **5-01-31-430-074**.
3. This contract is ratified from January 1, 2025 until the date of adoption of this authorizing resolution.
4. The within Resolution shall be maintained on file and available for public inspection in the office of the Borough Clerk.
