

RESOLUTION KENILWORTH, NJ

2025 MUNICIPAL BUDGET INTRODUCTION

WHEREAS, it is necessary for the Borough of Kenilworth to prepare an annual budget identifying all of the anticipated appropriations and revenues to support government operations for the Calendar Year 2024; and

WHEREAS, N.J.S.A. 40A:4-5 provides for the introduction and approval of the annual Municipal Budget; and


WHEREAS, upon approval of the introduction, a public hearing will be scheduled for comments.

NOW, THEREFORE, BE IT RESOLVED by the Borough of Kenilworth, County of Union, New Jersey, that:

1. The Municipal Council approves the introduction of the attached following statements of revenues and appropriations for the Borough of Kenilworth Municipal Budget for the year 2024.
2. The Governing body of the Borough of Kenilworth's approval of the introduction of the attached Budget for the year 2024 shall constitute a first reading, pursuant to N.J.S.A. 40A:4-5(a).
3. The public hearing and second reading for the Borough of Kenilworth Municipal Budget for the year 2024 will be held on April 17, 2024, at 6:00 PM at 567 Boulevard, Kenilworth, New Jersey.
4. The introduction and approval of the attached following statements of revenues and appropriations for the Borough of Kenilworth Municipal Budget for the year 2024 shall be published in the Local Source in the issue of March 28, 2024, which constitutes ten days prior to second hearing on April 17, 2024, pursuant to N.J.S.A. 40A:4-6.
5. Three certified copies of the approved budget shall be transmitted to the Director of the Division of Local Government Services within three days after approval, pursuant to N.J.S.A. 40A:4-5(b).
