

**RESOLUTION

**RESOLUTION PERMITTING ATLANTIC PLUMBING SUPPLY
TO PAVE A PORTION OF LINDEN STREET AND AUTHORIZING THE SIGNING OF AN AGREEMENT
WITH ATLANTIC PLUMBING SUPPLY TO EFFECTUATE THE TERMS OF THIS RESOLUTION**

WHEREAS, Atlantic Plumbing Supply, located at 820 Colfax Avenue (Block 174, Lot 1 on the Borough of Kenilworth Official Tax Map) has requested permission to repave the portion of Linden Street that runs alongside its facility, at its own expense and at no cost to the Borough; and

WHEREAS, the portion of Linden Street located adjacent to 820 Colfax Avenue (Block 174, Lot 1) is in a deteriorated state and is in need of being repaved; and

WHEREAS, Atlantic Plumbing Supply has agreed to work with the Borough and its professionals to ensure that the repaving work is performed in accordance with all applicable laws and regulations; and

WHEREAS, Governing Body believes it is in the best interests of the Borough and its citizens to permit Atlantic Plumbing Supply to repave the portion of Linden Street located adjacent to 820 Colfax Avenue (Block 174, Lot 1) at its own expense and at no cost to the Borough.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Kenilworth, County of Union, State of New Jersey as follows:

1. Atlantic Plumbing Supply shall be permitted to repave the portion of Linden Street adjacent to 820 Colfax Avenue (Block 174, Lot 1) at its own expense and at no cost to the Borough in accordance with the terms of an Agreement to be entered into between Atlantic Plumbing Supply and the Borough.
2. The Borough Attorney and such other Borough officials, employees, and professionals as needed are hereby authorized and directed to negotiate an Agreement with Atlantic Plumbing Supply to effectuate the terms of this Resolution.
3. The Mayor and Borough Clerk are hereby authorized to execute an Agreement between the Borough of Kenilworth and Atlantic Plumbing Supply once prepared, that incorporates all of the agreed upon terms.
