

## RESOLUTION KENILWORTH, NJ

**WHEREAS**, it is the interest of the Borough of Kenilworth, County of Union, State of New Jersey, to reimburse retirees for their payments for Part B of Medicare coverage for the period of January 1, 2025 through June 30, 2025; and


**WHEREAS**, N.J.S.A. § 52:14-17.38(b) allows for the Borough, upon adoption of a resolution, to reimburse a retired employee and their spouse covered for the retiree's premium charges under Part B of Medicare who meet the specifications as set forth under the statute.

**NOW THEREFORE, BE IT RESOLVED** by the Governing Body of the Borough of Kenilworth, County of Union, New Jersey, that:

1. The following list of Retirees be reimbursed for their payments for Medicare Part B coverage from January 1, 2025 through June 30, 2025 for the total inclusive amount of \$37,470.54, as set forth in the list below, in accordance with N.J.S.A. § 52:14-17.38(b), and State of New Jersey having been duly audited and found to be correct, are hereby ordered paid, and that warrants be drawn for the necessary obligations by the Chief Finance Officer (CFO) prior to the next regularly scheduled Council Meeting.
2. In the event of the CFO's absence, the Governing Body authorizes Assistant Finance Officer Lisa Wood to carry out the duties and responsibilities of the CFO as outlined in Borough Code Chapter 5-4.
3. The CFO has certified that sufficient uncommitted funds are available in the 2025 Borough of Kenilworth Budget to fund the payment of the following bills attached hereto and made a part of this resolution.
