

RESOLUTION KENILWORTH, NJ

RESOLUTION AUTHORIZING EXECUTION OF A SHARED SERVICE AGREEMENT BETWEEN THE BOROUGH OF KENILWORTH & THE BOROUGH OF ROSELLE PARK FOR PUBLIC WORKS SERVICES

WHEREAS, the Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-1 et seq., (the "Act") permits units of local government to share services for a particular purpose and to effectuate agreements for any service or circumstance that will aid and encourage a reduction of local expenses; and

WHEREAS, the Borough Kenilworth and the Borough of Roselle Park are public bodies corporate and politic of the State of New Jersey and are authorized under New Jersey law to enter into a Shared Services Agreement pursuant to the Act; and

WHEREAS, the Borough of Kenilworth and the Borough of Roselle Park desire to enter into a shared services agreement for the utilization of public works related equipment and services; and

WHEREAS, representatives of Kenilworth Borough and the Borough of Roselle Park have negotiated a Shared Services Agreement, a copy of which is annexed hereto as Exhibit A, and the terms of which are incorporated into this resolution as if set forth at length herein; and

WHEREAS, it is the intention of the parties that the new agreement will supersede and replace any previous shared services agreements for public works related services; and

WHEREAS, it is in the best interest of the Borough of Kenilworth to enter into the proposed Municipal Shared Services Agreement with the Borough of Roselle Park, as outlined in the Shared Services Agreement at Exhibit A.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Borough Council of the Borough of Kenilworth, County of Union, as follows:

1. That the appropriate officials be and are hereby authorized to execute the Shared Services Agreement with the Borough of Roselle Park for the use of public works equipment and services in substantially the form of the Shared Services Agreement annexed hereto and made a part hereof;
2. The Borough Clerk is hereby directed to forward a duly certified copy of this Resolution to the Borough Administrator, Superintendent of the Department of Public Works and the Borough of Roselle Park and NJ Department of Local Government Services.
