

ORDINANCE NO. 2025-08

AN ORDINANCE OF THE BOROUGH OF KENILWORTH AMENDING THE EXISTING CHAPTER 190 "VEHICLES AND TRAFFIC", SECTION 43 "SCHEDULE XI: STOP INTERSECTIONS", WITHIN THE BOROUGH OF KENILWORTH, COUNTY OF UNION, STATE OF NEW JERSEY

Purpose: The purpose of this Ordinance is to amend Chapter 190-43 "Schedule XI: Stop Intersections" to add a four-way stop at the intersection of Sheridan Avenue and 11th Street.

BE IT HEREBY ORDAINED by the Council of the Borough of Kenilworth, County of Union, State of New Jersey as follows:

NOW THEREFORE, Existing Chapter 190 "Vehicles and Traffic", Section 43 "Schedule XI: Stop Intersections" be amended to include the following:

§ 190-43 Borough Roadways

In accordance with the provisions of § 190-13, the following described intersections are hereby designated as stop intersections:

Intersection

Lafayette Avenue and North 16th Street

North 17th Street and Sheridan Avenue
[Added 3-10-2010 by Ord. No. 2010-04]

Richfield Avenue and South 25th Street

Roosevelt Lane and Arbor Street

Stop Sign On

North 16th Street

Both sides of North 17th Street and Sheridan Avenue

South 25th Street

Arbor Street

North 11th Street and Sheridan Avenue

Both sides of North 11th Street and Sheridan Avenue

Severability

If any section, subsection, paragraph, sentence, clause or phrase of this Ordinance shall be declared invalid for any reason whatsoever, such decision shall not affect the remaining portions of this Ordinance, which shall continue in full force and effect, and to this end, the provisions of this Ordinance are hereby declared to be severable.

Repealer

All Borough ordinances and parts of ordinances that are inconsistent with this ordinance are hereby repealed.


Effective Date
