

## RESOLUTION KENILWORTH, NJ

Municipal Council adopted Resolution 25-112 awarding a NJ State Cooperative (Buy Board #679-22, Custom Shelter Design) purchase to Superior Recreation Products, Quote QUO030 for the construction and installation activities associated with the DiMario Park Pavillion project in an amount not to exceed \$125,875.39.

**WHEREAS**, to remediate existing drainage issues the Borough of Kenilworth directed the contractor to install leaders, gutters and a trench drain, the additional work requires a change order (N.J.A.C. 5:34-11-8(c)(1); and

**WHEREAS**, the amount of the change order is less than the aggregate maximum increase of 20% as required by N.J.A.C 5:34-11-3(a)(9); and


**WHEREAS**, the Borough wishes to authorize a Change Order No. 1 for the supplemental work as recommended by the Borough Engineer (attached).

Attached is Change Order No. 1 and a revised quote from Superior Recreational Products for additional work required for the installation of a new pavilion at DiMario Park.
