

In response to your request we are pleased to present the following proposals for your consideration.  
Our scope of work shall consist of the following:

1. Remove and dispose of existing concrete pad. Remove and dispose of existing concrete slab under water storage tank. Install precast oil separator supplied by others. Install overflow pipe from oil separator to existing E inlet. Excavate prep and pour 20'x50' concrete pad 6" thick wire mesh reinforced with class B DOT concrete. Use  $\frac{3}{4}$  clean stone to properly pitch slab. Install 20' trench drain 6" wide across apron. Connect to oil separator supplied by others. Dispose of all excavated material
  - i. \$23,400 twenty three thousand four hundred dollars

- Police traffic control if required
- Repaving outside our saw cut limits
- Permits and or permit fee's
