

ORDINANCE 2025-13

AN ORDINANCE REPEALING AND AMENDING CHAPTER 37, ARTICLE II, SECTION 37-9 A AND B OF THE CODE OF THE BOROUGH OF KENILWORTH TO ALIGN WITH BEST PRACTICES OF MUNICIPAL EXCESS LIABILITY AND JOINT INSURANCE FUNDS IN THE STATE OF NEW JERSEY

WHEREAS, the New Jersey Municipal Excess Liability and Joint Insurance Funds (hereinafter referred to as "NJMEL") provide liability coverage to the Borough of Kenilworth; and

WHEREAS, NJ MEL recommends that all employee benefit policies be set forth in the Borough Personnel Policies and Procedures Manual and any duplications of such policies be removed from the Borough Code; and

WHEREAS, the Governing Body of the Borough of Kenilworth seeks to repeal Chapter 37, Article II, Section 37-9 A and B in response to the recommendation of the NJMEL; and

NOW THEREFORE, BE IT ORDAINED by the Governing Body of the Borough of Kenilworth, County of Union, State of New Jersey, as follows:

SECTION 1. Chapter 37, Article II, Section 37-9 A and B of the Borough Code, is hereby repealed in its entirety.

SECTION 2. Effective Date


This ordinance shall take effect upon final passage and publication as required by law.

If any section, paragraph, subdivision, sentence, clause, or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, sentence, clause, or provision so adjudged and the remainder of this Ordinance shall remain valid and effective.

SECTION 4. Any ordinances or parts thereof in conflict with the provisions of this Ordinance are repealed to the extent of such conflict.
