

RESOLUTION KENILWORTH, NJ

WHEREAS, after the proper advertisement of same, pursuant to the Local Public Contracts Laws, N.J.S.A. 40A:11-1 et seq., the Borough of Kenilworth received sealed bid on September 25, 2025, for the construction and related activities associated with the provision of the **2025 NJDOT Roadway Improvements** (Monroe Avenue and 12th Street) project; and

WHEREAS, the Borough Engineer, Harbor Consultants, Inc., has provided the hereto attached summary of the bid results and has recommended that the lowest responsible bid be awarded to **S. Brothers Inc.**, PO Box 317, South River, NJ ("S. Brothers Inc."); and

WHEREAS, the Borough Council has determined that it is in the best interest to accept the bid proposal and execute a contract for the **2025 NJDOT Roadway Improvements** project, with the lowest responsible bidder, **S. Brothers Inc.**, in an amount not to exceed **\$493,140.32 for the Base Bid 1, 2 and 3 and Alternate Bids 1 & 2.**; and

WHEREAS, the public advertisement, the receipt of public bids and the award of the contract to the lowest responsible bidder, pursuant to the Local Public Contracts Law, N.J.S.A. 40A:11-1, et seq., for the **2025 NJDOT Roadway Improvements** project, constitutes a Fair and Open Process pursuant to the Local Pay to Play Law, N.J.S.A. 19:44A:20.5, et seq.

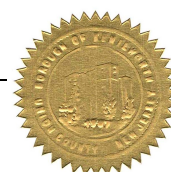
NOW, THEREFORE, BE IT RESOLVED by the Borough of Kenilworth, County of Union, NJ, that:

1. The Mayor and Council are hereby authorized to accept the bid submitted by the lowest responsible bidder, **S. Brothers Inc.**, PO Box 317, South River, NJ, for the **2025 NJDOT Roadway Improvements** project in the amount not to exceed **\$493,140.32** for the Base Bid 1, 2, 3 and Alternate Bids 1 & 2.
2. The Mayor is authorized to enter into and execute a contract with **S. Brothers Inc.** for the **2025 NJDOT Roadway Improvements** project, in an amount not to exceed **\$493,140.32 for the Base Bid 1, 2 and 3 and Alternate Bids 1 & 2.**
3. This contract is being awarded pursuant to the Fair and Open Procedures of the Pay to Play Law, N.J.S.A. 19:44A-20.5, et seq. and in accordance with the public bid procedures pursuant to the Local Public Contracts Law, N.J.S.A. 40A:11-1, et seq.
4. No changes to this contract shall be allowed or authorized without prior Municipal Council approval.
5. There shall be no advance payments made against this contract in accordance with NJAC 40A:5-16.
6. A fully executed copy of the contract shall be filed in the Office of the Borough Clerk.
7. The contract shall commence upon the issuance of a notice to proceed by Harbor Consultants, Inc. and shall be completed according to the terms of the contract.
