

**RESOLUTION**  
**KENILWORTH, NJ**

**WHEREAS**, the State of New Jersey Department of Military and Veterans Affairs has confirmed that the resident owner of the property located at 349 Maplewood Ave (Block 169, Lot 5) was granted a determination of 100% total disability by the United States Department of Veterans Affairs, and

**WHEREAS**, the resident property owner of Block 169 Lot 5 has made an application to the Tax Assessor for an exemption from property taxes on the above address based on their disabled veteran's status under N.J.S.A. 54:4-3.30; and

**WHEREAS**, it is recommended by the tax assessor, Kevin Palumbo, in a letter dated October 7, 2025, to the tax collector that the resident property owner of Block 169 Lot 5 shall be granted a full tax exemption from billed property taxes as of October 1, 2025, and this has resulted in an overpayment of 2025 taxes due.


**NOW, THEREFORE, BE IT RESOLVED**, by the Governing Body of the Borough of Kenilworth, County of Union, State of New Jersey, that the resident owner of Block 169 Lot 5 be granted a full tax exemption from property taxes billed to 349 Maplewood Ave Kenilworth, NJ, as of October 1, 2025, and that the overpayment of taxes be refunded per the amount below.

**BE IT FURTHER RESOLVED**, that the tax break will only be in effect for as long as the disabled veteran owner owns the property. Should the property be sold to someone other than the disabled veteran and/or if the deed is changed removing the disabled veteran owner that the tax break will no longer be in effect and the property will be subject to conventional taxes.
