

ORDINANCE 2025-14

AN ORDINANCE OF THE BOROUGH OF KENILWORTH AMENDING THE EXISTING CHAPTER 190-34 VEHICLES AND TRAFFIC, SCHEDULE II: NO PARKING CERTAIN HOURS BY SPECIFYING AN ADDITIONAL AREA TO THE CODE OF THE BOROUGH OF KENILWORTH, COUNTY OF UNION, STATE OF NEW JERSEY

BE IT HEREBY ORDAINED by the Borough Council of the Borough of Kenilworth in the County of Union and the State of New Jersey as follows:

Purpose:

The purpose of this Ordinance is to supplement Chapter 190 VEHICLES AND TRAFFIC whereby the Borough Council seeks to promote the public safety and welfare within the Borough, by:

1. the elimination of vehicular congestion that impedes or otherwise restricts the safe ambulatory transportation of developmentally disabled persons to and from the location identified as 355 Maplewood Avenue during specific hours and days; and

Article VII Schedules

190-34 Schedule II: entitled "No Parking Certain Hours"

Is amended to include the following specified area within the Borough as a no parking zone between the hours specified upon the following described street or part of street:

Severability


