

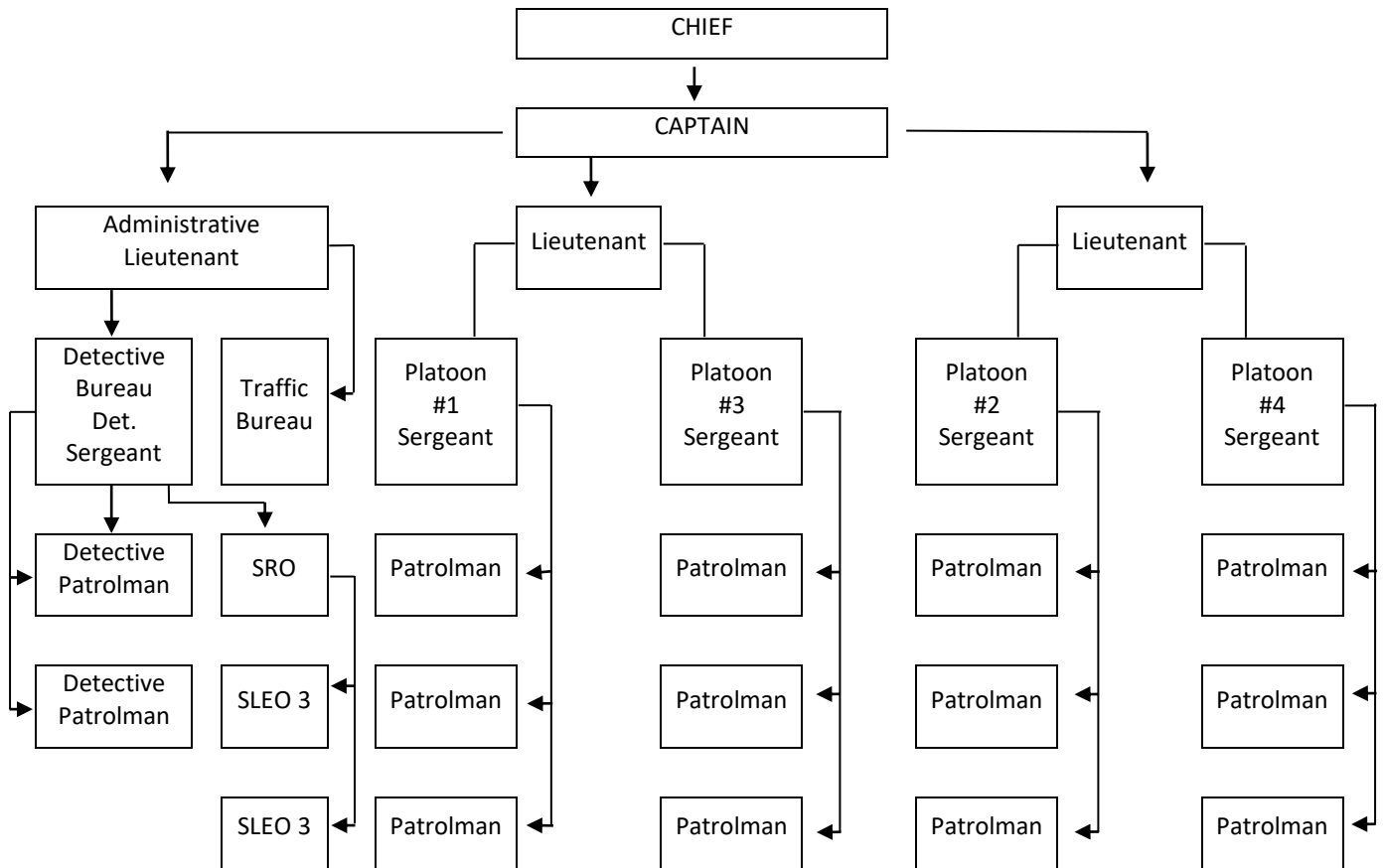
**ORDINANCE NO. 2021-12**  
**AN ORDINANCE AMENDING CHAPTER 15 “DEPARTMENTAL STRUCTURES” AND CHAPTER 48**  
**“TRAFFIC BUREAU” OF THE CODE OF THE BOROUGH OF KENILWORTH, COUNTY OF UNION,**  
**STATE OF NEW JERSEY**

**Purpose:** The Purpose of this ordinance is to amend Chapter 15 “Departmental Structures” and Chapter 48 “Traffic Bureau” in accordance with current practices and policies of the Kenilworth Police Department.

**BE IT HEREBY ORDAINED** by the Governing Body of the Borough of Kenilworth, County of Union, New Jersey, that it is hereby amending Chapter 15 to the Code of the Borough of Kenilworth as follows:

**DEPARTMENTAL STRUCTURE**

Section 15.2 Police Department Table of Organization – As follows:



**BE IT FURTHER RESOLVED**, that the following amendments be made to **Chapter 48 Traffic Bureau**:

1. The term “superior” be removed from Chapter 48-2 “Membership”.
2. Chap 48-3 “Supervisor” shall be deleted in its entirety.
3. The term “Supervisor” shall be replaced with “Traffic Officer” throughout Chapter 48-4 “Duties” and 48-5 “Designation of Members and ~~Supervisor~~ **Traffic Officer**”

**Severability**

If any section, subsection, paragraph, sentence, clause or phrase of this Ordinance shall be declared invalid for any reason whatsoever, such decision shall not affect the remaining portions of this Ordinance, which shall continue in full force and effect, and to this end, the provisions of this Ordinance are hereby declared to be severable.

**Effective Date**

This Ordinance shall take effect twenty (20) days after the first publication thereof after final passage as provided by law.
