

ORDINANCE 2018-08

AN ORDINANCE OF THE BOROUGH OF KENILWORTH AMENDING THE EXISTING CHAPTER 190 VEHICLES AND TRAFFIC BY PROHIBITING PARKING FROM THE NORTH EAST CORNER OF MARKET STREET AND WEST COLFAX AVENUE BY 50 FEET IN EACH DIRECTION WITHIN THE BOROUGH OF KENILWORTH, COUNTY OF UNION, STATE OF NEW JERSEY

Purpose:

The purpose of this Ordinance is to supplement Chapter 190 VEHICLES AND TRAFFIC whereby the Borough Council seeks to promote the public safety and welfare within the Borough, by the elimination of vehicles left attended or unattended on the street unless a clear and unobstructed view of vehicles approaching an intersection may be viewed.

BE IT HEREBY ORDAINED by the Council of the Borough of Kenilworth County of Union and the State of New Jersey as follows:

NOW THEREFORE, Chapter 190-33 Schedule I: entitled "No Parking" is amended to include the following two specified areas within the Borough as no parking zones:

<u>Name of Street</u>	<u>Side</u>	<u>Location</u>
Market Street	East	From north side corner of West Colfax Avenue for 50 feet
West Colfax Avenue	North	From the East side of Market Street for 50 feet

Severability

If any section, subsection, paragraph, sentence, clause or phrase of this Ordinance shall be declared invalid for any reason whatsoever, such decision shall not affect the remaining portions of this Ordinance, which shall continue in full force and effect, and to this end, the provisions of this Ordinance are hereby declared to be severable.

Effective Date

This Ordinance shall take effect twenty (20) days after the first publication thereof after final passage as provided by law and the painting of the curb yellow or no parking signs posted.
