**ORDINANCE TO AMEND RECREATIONAL PROGRAM FEES IN SECTION 91-6, ARTICLE III,
ENTITLED "FEES FOR PARTICIPATION IN PROGRAMS"**

PURPOSE: The purpose of this Amendment is to update the schedule of fees charged by the Borough to offset the costs for participation in recreational programs.

NOW, THEREFORE, BE IT ORDAINED, by the Council of the Borough of Kenilworth, County of Union, and the State of New Jersey as follows that Section 91-6 is amended as follows:

The Recreation Committee of the Borough of Kenilworth shall charge fees per season for each participant in the following program(s).

C. Basketball

Kindergarten through 2 nd grade Clinic:	\$50 per child per season
3 rd Grade through 5 th Grade instruction:	\$75 per child per season
6 th Grade through 8 Grade instruction:	\$75 per child per season

D. Cheer Clinic: \$20 per child per season

E. Softball

Kindergarten through 2 nd grade Clinic:	\$50 per child per season
3 rd through 5 th Grade instruction:	\$75 per child per season
6 th through 8 th Grade instruction:	\$75 per child per season

F. Flag Football: \$25 per person per season

H. Summer Camp Kindergarten through 7th Grade:

Day Camp: \$75 for a calendar week, Monday through Friday
Day Camp: \$45 for no more than three (3) days in a calendar week
After Care: \$40 for four (4) or five (5) days in a calendar week (no sibling discount)
After Care: \$24 for up to three (3) days in a calendar week (no sibling discount)

If more than one child from the same family or resides in the same home attends Day Camp for the entire week, then each child shall be entitled to a reduction of ten dollars (\$10.00)


J. Homework Club: 3rd grade to 8th grade: \$200 per month or any portion thereof of the month

K. Soccer Program: 6th grade to 8th grade instruction: \$180 per person per season


Any Ordinance inconsistent with the foregoing is repealed to the extent of any inconsistency.
